## WALTON PARK SIDEWALK, PHASE II:

The scope of the project is to construct a sidewalk along the west side of Walton Park Road in Chesterfield County, VA. The project begins at the intersection of Walton Park Road and Watch Hill Road and ends at the intersection of Walton Park Road and N. Woolridge Road. The sidewalk improvements consist of approximately 3,350 linear feet of curb and gutter and sidewalk, including associated storm sewer and drainage structures as well as minor pavement widening and grading.
