Introduction:

It should not be construed as intent, commitment, or promise to acquire an organization's or individual's services, skills, or expertise.

Information submitted in response to this RFI will become the property of ChildPlus Software. ChildPlus will not pay for any information provided nor is it liable for any costs incurred by any organization.

Objective:

The objective of this project is the development of a child development assessment instrument for use within ChildPlus Software. We are seeking organizations and/or individuals with appropriate knowledge, experience, and credentials to develop an assessment instrument and guide the process for its implementation including the construction of instrument items; determining the skills, attributes, credentials, and experience for the development team, whose roles could include developers, editors, researchers, assessors, or advisors; and to guide validity and reliability field testing. The tool should meet the criteria outlined in the NAEYC-NAECS/SDE Position Statement on Curriculum, Assessment and Program Evaluation, align with the Head Start Early Learning Outcomes Framework, and consider individual state early learning guidelines. It is essential the tool be determined valid and reliable, developmentally appropriate for children birth to five, adaptive for children with disabilities, and responsive to cultural and linguistic differences.

Summary:

The assessment tool will allow early childhood professionals to make decisions for teaching and learning for both individuals and groups of children and identify and promote ongoing program improvement. It will support children's learning and drive instruction, identify children in need of additional support or intervention, be a component of overall program evaluation, monitor trends for teacher professional development, and promote continuous program improvement.

Assessment methods used in the tool should be developmentally and linguistically appropriate. The tool should be comprehensive, utilize authentic methods of assessment, and include developmentally and educationally significant goals that support existing early childhood curricula currently used by practitioners and align with early learning standards including the Head Start Early Learning Outcomes

Framework and reflect state early learning guidelines for infants, toddlers and pre-school children. ChildPlus has a long-term goal of developing an early childhood curriculum aligned with the assessment instrument.

Intellectual Property and Copyright:

We anticipate crediting the author(s) and/or associated organizations when referencing the instrument, but the sole compensation to the author(s)/organizations will be the agreed upon cost of the development of the instrument. It is the desire of ChildPlus to use the instrument in perpetuity without the payment of royalties, licensing, fees, or any other amount to the author(s)/organizations. The resultant instrument will be the sole property of ChildPlus Software.

Deliverables:

- Initially, the tool will be developed as a hard copy set of materials that can easily be digitized
 and incorporated into the ChildPlus Software system. This RFI only addresses the hard copy
 materials;
- The development of an instructional manual to ensure the instrument will be used as intended;
- The development and facilitation of training for ChildPlus staff who will in turn train and coach program education managers and staff;

Project Budget Statement:

Our goal for this project is to create the highest quality assessment instrument possible; therefore, ChildPlus is prepared to substantially fund this project.

Expected Project Timeline:

This project is a high priority for ChildPlus and our objective is to expedite the development of the tool; however, we do realize a project of this scale takes time. We anticipate that from the onset of the project to the roll out of the valid and reliable assessment tool and materials, this project could span 12 to 24 months.
