Sealed bids will be received by the County of Somerset on **THURSDAY JULY 28, 2011 at 2:30 PM** in the Second Floor Engineering Conference Room, County Administration Building, 20 Grove Street, Somerville, New Jersey for “SPOOKY BROOK GOLF COURSE CLUBHOUSE INTERIOR FINISH RENOVATIONS, LOT 11, BLOCK 511, 582 ELIZABETH AVENUE, FRANKLIN TOWNSHIP, SOMERSET COUNTY, NEW JERSEY, CONTRACT NUMBER 11023.”

Specifications and Forms of Bid for the proposed project, prepared by the County of Somerset, Office of the County Engineer and filed in the County Administration Building, 20 Grove Street, Somerville, New Jersey and may be inspected by the prospective bidders during business hours **on or after June 30, 2011**. Bidders will be furnished with a copy of the specifications upon request.

Copies of bid documents may be obtained by prospective bidders for a document **fee of \$75.00 NON-REFUNDABLE** in the form of a check payable to Somerset County Treasurer will be required for each set of documents taken out by prospective bidders.

The contract includes but is not limited to the following major items of work:

- Renovation of Clubhouse interior
- Replacement of existing windows

A Pre-bid conference will be held on Tuesday July 12, 2011 at 10:00AM at the project site, Spooky Brook Golf Course Clubhouse, 582 Elizabeth Avenue, Franklin Township, New Jersey 08873. Attendance by all prospective bidders and their sub-contractors and suppliers is not mandatory. Questions relating to this project will be responded to at this time.

Bids must be made on the standard proposal form, must be enclosed in a sealed envelope bearing the name and address of the bidder on the outside, addressed to Mary Louise Stanton, Purchasing Agent, County Administration Building, 20 Grove Street, Somerville, New Jersey, clearly marked on the outside, “SPOOKY BROOK GOLF COURSE CLUBHOUSE INTERIOR FINISH RENOVATIONS, LOT 11, BLOCK 511, 582 ELIZABETH AVENUE, FRANKLIN TOWNSHIP, SOMERSET COUNTY, NEW JERSEY, CONTRACT NUMBER 11023.”, and must include Surety in the form of a Proposal Bond (only on the form herein provided), Certified Check or Cashier's Check in the amount of 10% of such bid, but not exceeding \$20,000.00 payable to the Somerset County Treasurer, and that said Surety Company will furnish a Performance Bond and Payment Bond in amounts of 100% of successful bidder's contract.
