Background of Idaho Association for the Education of Young Children, Inc. (Idaho AEYC)

The Idaho Association for the Education of Young Children (Idaho AEYC) is a 501(c)(3), non-profit organization committed to promoting excellence in early child care and education. We are dedicated to quality child care and strong families. Idaho AEYC's mission is to improve professional practice in early care and education, build public understanding and support of quality early child care in our communities, and maintain a strong, diverse and inclusive organization.

Idaho AEYC was created in 1986 as a professional membership and advocacy organization supporting educators interested in improving early childhood education. Since its inception, Idaho AEYC is the proud initiator of innovative and nationally recognized projects such as the IdahoSTARS Professional Development System which includes the Steps to Quality program (STQ), and the Idaho's Strengthening Families Initiative (a child abuse prevention program)

Idaho AEYC is largely supported through a federal Child Development Block Grant. This funding is delivered to the Idaho State Department of Health and Welfare who contracts directly with University of Idaho's Center on Disabilities and Human Development. Idaho AEYC is a subcontractor of University of Idaho.

Project Summary

Currently, Idaho AEYC uses several Access database applications in conjunction with NACCRRAware in order to keep records for the IdahoSTARS project. Recently Idaho AEYC has encountered issues regarding record keeping. At the moment there are several systems that enter data that are not connected to each other, which lead to data duplication and other problems. When there is a data discrepancy the NACCRRAware system is the most updated system to verify the integrity of the other databases. Idaho AEYC needs to integrate a centralized system to reduce the amount of duplicate and bad data that is entered.

In order to better serve our stakeholders, we have elected to update this system by April 2016. In addition to the ways we currently use our system, we also want the ability to consolidate the training database, and add additional features as specified in the Solutions Requirements Workbook.

It should be noted that this project is dependent on the availability of funds and should funding for this project cease or decrease the projects scope or existence will react commensurately.

Goals

In order to meet the needs of its stakeholders, Idaho AEYC has outlined the following metrics for the successful integration of a new database into the organization's current practices:

- Create SQL Server database that integrates currently developed Access Databases of Scholarships, Professional Development System (PDS), and Steps to Quality (STQ) with the Training Database which is already in MSSQL
- Integrate NACCRRAware data elements into new SQL Server database using web services
- Staff training and customer support
- Develop convenient web based user interfaces based on current Access Applications
- Ensure developed database can be integrated with Department of Health and Welfare (DHW) in the future

Ownership

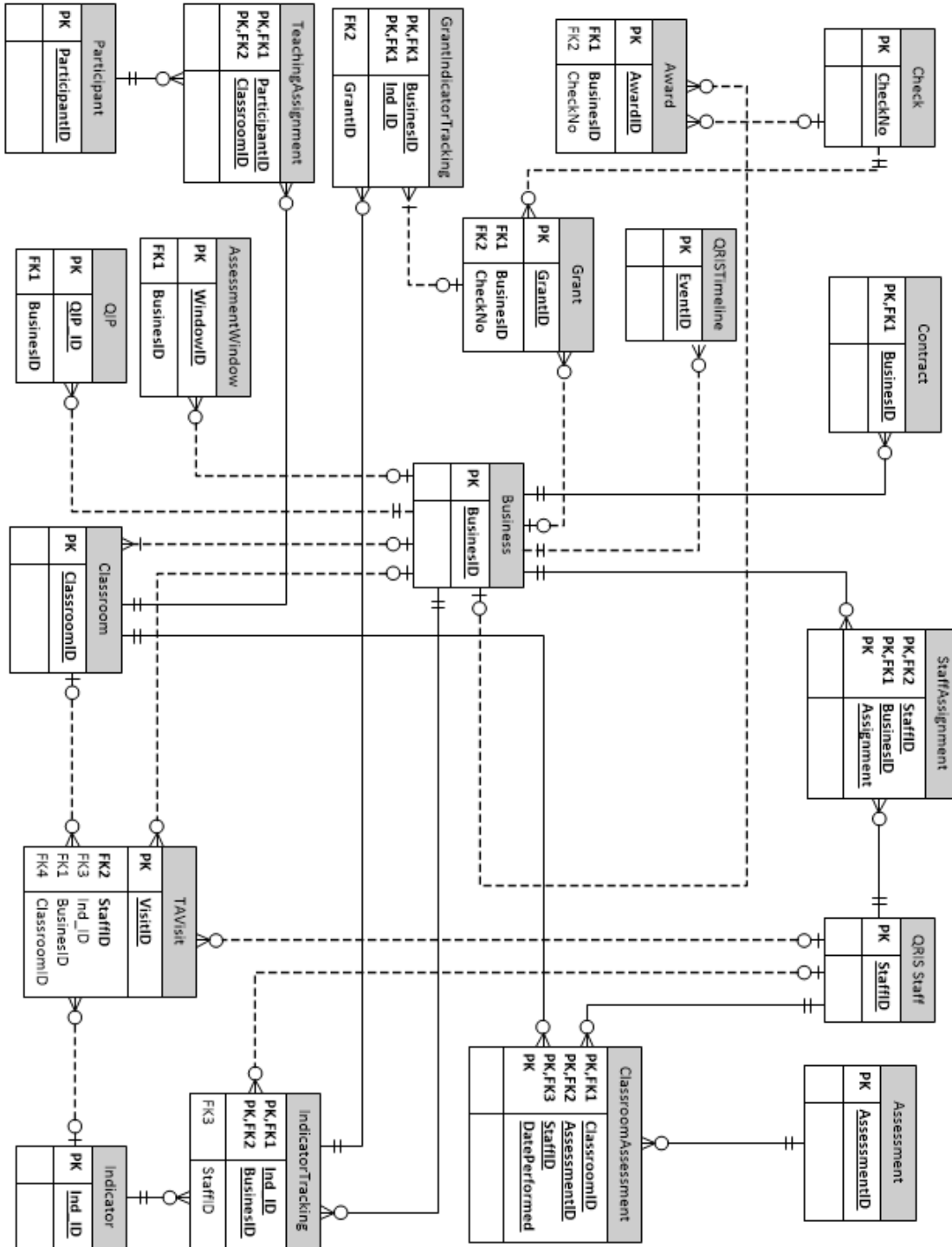

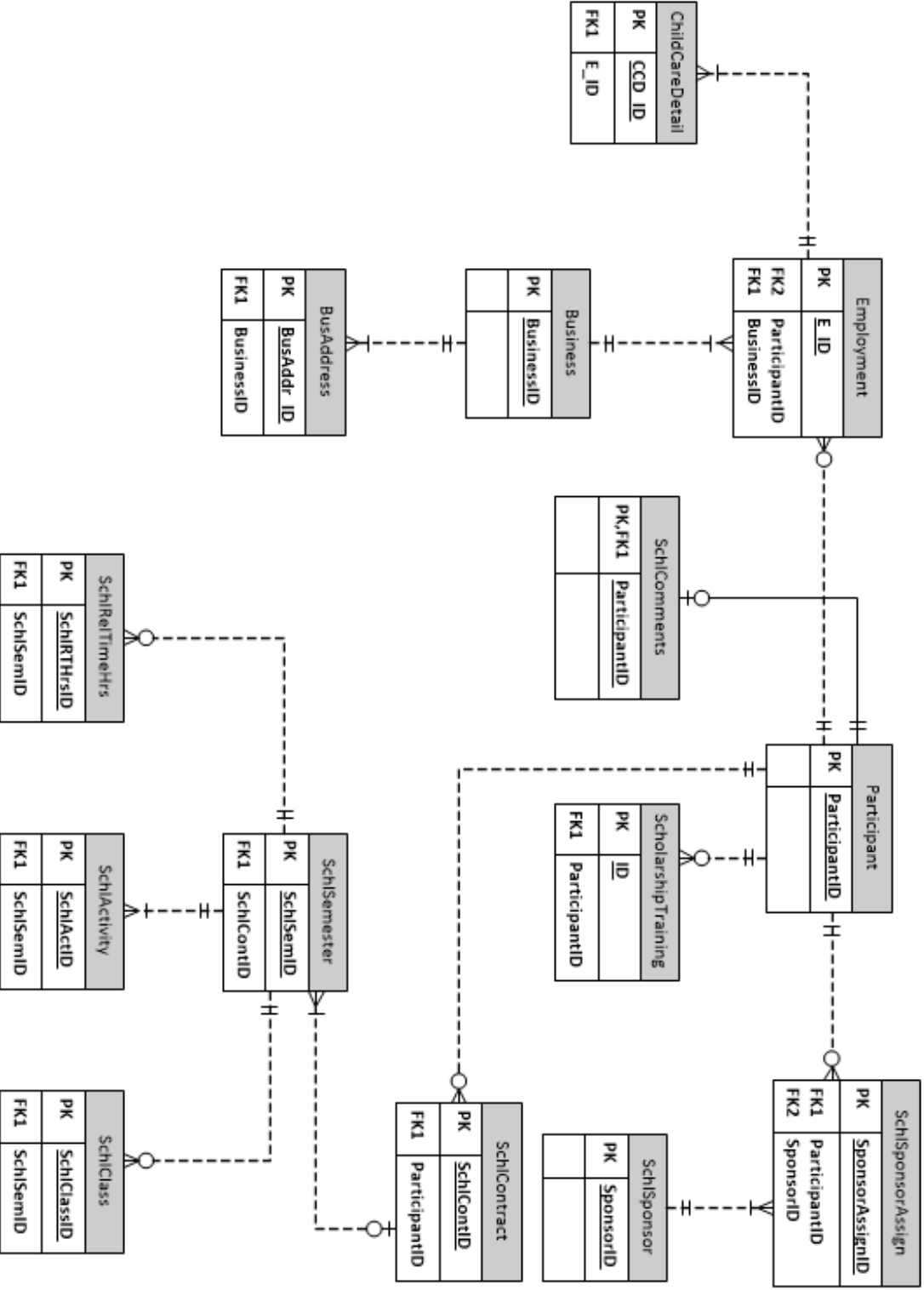

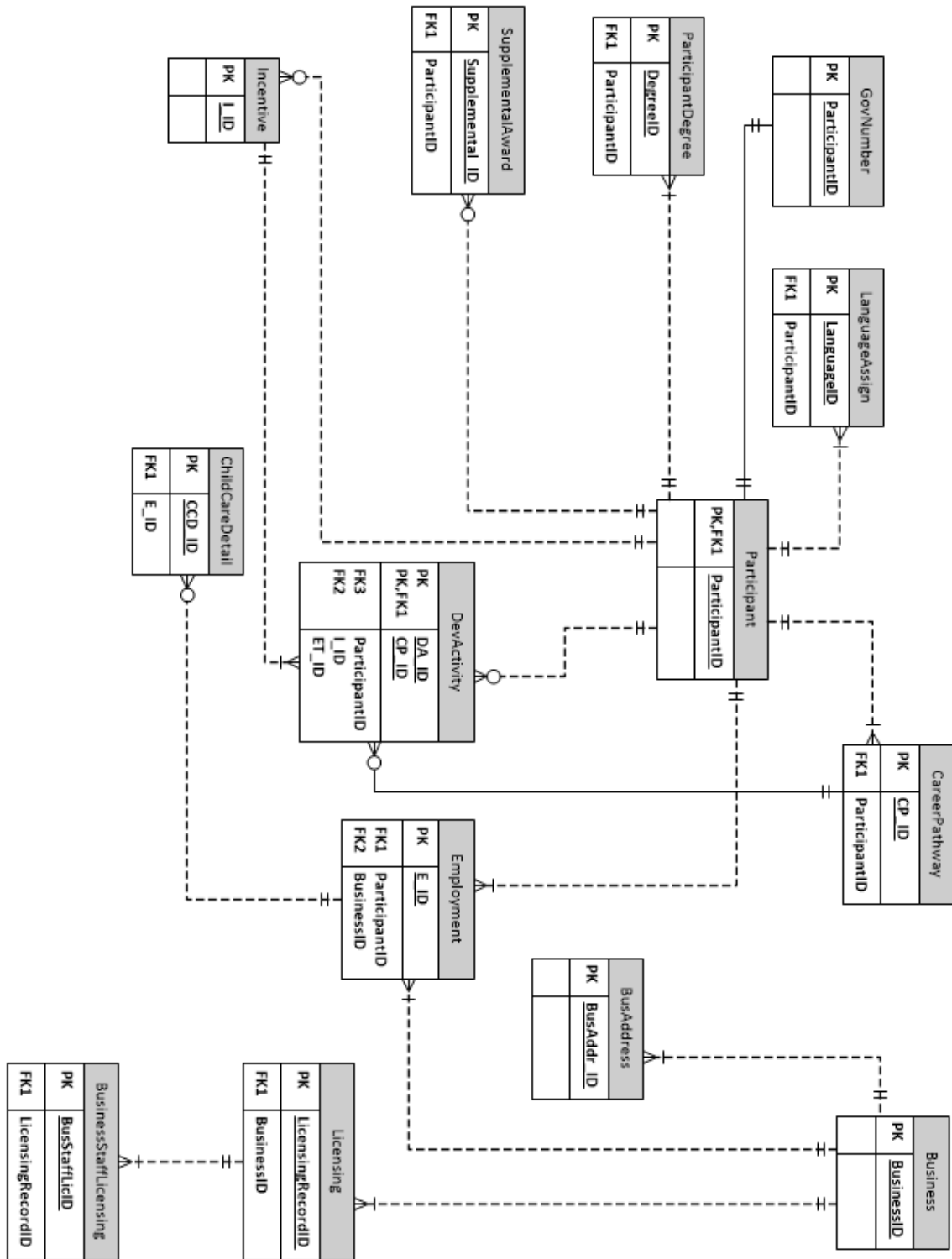


Appendix B: Scholarship ERD
