Jones Sausage Road Widening & Realignment/Rock Quarry Road Widening, Part B

Pursuant to the General Statutes of North Carolina, Section 143-128 et. seq, sealed proposals are invited and will be received by the City of Raleigh in the office of the Public Works Director until 2:00 p.m. Wednesday, December 8, 2010 at which time at a meeting in Room 400, 222 W. Hargett Street, Raleigh, N. C., the sealed proposals will be publicly opened for construction consisting of furnishing and installing the following:

Approximately 16,230 L.F. of roadway construction and 220' of bridge construction for the realignment and widening of Jones Sausage Road & Rock Quarry Road from I-40 to Sunnybrook Road. The work will generally consist of clearing, grading, storm drainage, utility relocations and adjustments, curb and gutter, paving, box culvert structure, sidewalk, traffic signals, traffic control, and other related items as shown on the plans. Structural items include new 220' single 4-span bridge over Big Branch Creek and a 183' long, quadruple 12'x10' box culvert.

A DVD containing digital copies of the plans in PDF format and a hard copy of the contract specifications may be obtained from the City of Raleigh on Monday, October 25, 2010 at 10:00 a.m. At such time as the DVD and contract specifications are obtained by individual prospective bidders, the bidder's contact information will be recorded on the project's official bidders list. Bidders not recorded on the project's official bidders list will not be eligible for bidding. A paper copy of the plans may be obtained in lieu of the DVD for a non-refundable fee of one hundred eighty dollars (\$180.00).

A pre-bid conference for all contractors, sub-contractors, minority and woman owned businesses will be held at the City of Raleigh on Wednesday, November 3, 2010 at 9:00 a.m. in Room 305, 222 W. Hargett Street, Raleigh, North Carolina.

From Monday, October 25, 2010 at 10:00 a.m. until the date of opening the proposals, plans and specifications of the proposed work are and will continue to be on file in the office of the Public Works Director, 222 W. Hargett Street, Raleigh, North Carolina, during usual office hours, and are available to prospective bidders. No proposal will be considered or accepted unless at the time of its filing, the same shall be accompanied by a cash deposit, cashier's check, or certified check on a bank or trust company insured by the FDIC and authorized to do business in North Carolina in an amount equal to five percent (5%) of the proposal. In the alternative, a five percent (5%) bid bond issued by a corporate surety licensed by the State of North Carolina may be filed with the proposal. Bidders must be properly licensed under Chapter 87 of the General Statues of North Carolina and must comply with nondiscrimination provisions. The City is an equal opportunity Municipality/Owner and invites small and minority contractors to bid. The City Council reserves the right to reject any or all proposals.
