ABOUT THE FORT OMAHA CAMPUS PUBLIC ART PROJECT



MCC is moving forward with our community partners to expand our facilities and prepare students for the workforce by creating a place where business and education thrive together. The Fort Omaha Campus will be home to three new academic centers:

Center for Advanced and Emerging Technology (CAET)

MCC's Center for Advanced and Emerging Technology is a regional hub for education, innovation and economic growth — a place where business and education thrive together. Both a driver and a consumer of new technologies, CAET will be a collaborative working and learning space that earns the label "synergistic." Corporate exhibit space, entrepreneurial production labs and economic development partners will be hallmarks of the new center. Construction Education Center (CEC)

ARTWORK SITE/TYPE OF ART SOUGHT/ENVIRONMENT

The committee is seeking a large exterior sculpture, installation, or environmental public art project. The proposed site of the commissioned artwork is in the highly visible central courtyard, with a base area spanning approximately 8 x 8 ft. However, the site could incorporate the entire 120 x 120 ft. courtyard. The work will represent the movement from a historic fort to a 21st Century learning environment while honoring donors and providing an identity for the expansion project on campus. Most importantly, the committee is seeking artists who can design, in an engaging manner, innovative, thought-provoking projects that relate to the proposed space.





SELECTION PROCESS

Selections will be made solely by the MCC Public Art Committee, composed of staff and community representatives in consultation with the Nebraska Arts Council. The committee will review submissions from this RFQ and choose three short-listed artists to present proposals.

The following factors will be considered when reviewing RFQ submissions:

- Quality of past work
- Appropriateness of subject/concept for the commission site
- Previous commission experience incuding, but not limited to, projects with comparable budgets
- Previous work that addresses issues of permanence, safety and maintenance commonly found in public art
