## REQUEST FOR PROPOSALS (RFP) No. 11-500196

## COMPUTER AIDED DISPATCH (CAD) PROCUREMENT CONSULTING SERVICES FOR DEKALB COUNTY, GEORGIA

DeKalb County Government (the County) requests qualified individuals and firms with experience in preparing Computer Aided Dispatch (CAD) for 911 Dispatch Centers to submit proposals for Computer Aided Dispatch Procurement Consulting Services for DeKalb County Police Services Department located at 1960 W. Exchange, Tucker, Georgia.

## I. INTRODUCTION

The successful Responder will prepare a separate and formal Request for Proposal (RFP) for a new Computer Aided Dispatch (CAD) and Mobile Client to be utilized by the 911 Center and emergency response vehicles. The Statement of Work provided within this packet identifies the tasks to be accomplished.

The successful Responder must meet the following minimum requirements:

- Possess 5 or more years of direct experience in preparing similar Computer Aided Dispatch RFPs.
- Must have prepared a CAD procurement RFP for a 911 Dispatch Center that receives a minimum of 750,000 incoming calls per year
- Must be able to demonstrate comprehension of the CAD System and 911 Center operations and goals using relevant examples.

• Must demonstrate a minimum of three (3) successful CAD Procurement engagements to organizations with similar size and scope to that of DeKalb County. Must provide the company name, person to contact, address and telephone number, description of work performed, and the total value of the Contract.

## **II. STATEMENT OF WORK**

The County intends to award a Computer Aided Dispatch (CAD) Procurement Consulting Services contract to a firm based on an evaluation of all proposals received. An outline of the work to be performed by the successful CAD Consulting firm is provided below:

- 1. Provide necessary staffing to perform all project related management tasks including support staffing needed to prepare required documentation, including meeting minutes and project schedule(s).
- Schedule and conduct on-site meetings with DeKalb County Public Safety Departments' representatives to include a sampling of users of the affected systems in order to assess the needs of each agency. This shall include site visits and ride along sessions with system users. All notes associated with these meetings shall be compiled and incorporated into project documents.
- 3. Detail the various components of the Public Safety Systems to include CAD, Records Management System (RMS), Mobile Data, Mapping, Field Base Reporting, Police Advanced Technology Solution (PATS) and all required interfaces and prepare a document that analyzes the current system and describes the needs for a replacement system. This shall include software, hardware, network, interface and support personnel recommendations. This includes recommendations based upon the Responder's knowledge of public safety systems, an assessment of the systems currently in use by the County, and an assessment of functional needs. This recommendation should specifically include analysis of integration with CAD or other systems. The Responder shall also consider interoperability with other CAD systems (CAD to CAD).
- 4. Develop a specification document based upon the needs analysis as stated in the scope of work. This document shall comply with current industry standards and incorporate functional specifications which will be included in the RFP for the procurement of the System(s). This document must be in compliance with the Standard Functional Specification for Law Enforcement CAD Systems as developed by the Law Enforcement Information Technology Standards Council (LEITSC) and also National Fire Protection Association 1221 Standard for the Installation, Maintenance and Use of Emergency Services Communications Systems. The specification document must also comply with applicable Association of Public Safety Communications Officials (APCO) and National Emergency Number Association Standards.
- 5. Assist in preparing RFP(s). The RFP(s) will outline all the requirements for the acquisition

of the replacement System(s) using DeKalb County's RFP requirements. This shall include recommendations of source selection criteria to be used by the County during the selection process. The Responder shall assist in the preparation of scripts to be used in the evaluation process for inclusion in the document and also assist in the development of recommended evaluation criteria that will be used by the County's Evaluation Committee during the evaluation process.

- 6. Be available to assist in the response to bidders' inquiries requesting additional information or clarification during the RFP process.
- 7. Assist as the technical expert in the evaluation meetings and prepare documentation to suggest the importance of each criterion in the weighted evaluation matrix for proposals received.
- 8. Attend the pre-proposal meeting(s) in coordination with County Procurement staff and assist in the preparation of Addendums that may be required.
- 9. Assist with the coordination and schedule bidders' interviews and site visits as required.
- 10. Assist DeKalb County Department of Purchasing and Contracting in any necessary preparation of Board of Commissioners documents for Contract award should it be necessary.
- 11. Attend required Board of Commissioners Finance and Operations Committee meetings and full Board of Commissioners meetings during the Contract award process.

## III. PROPOSAL FORMAT

Responders are required to submit their proposals in the following format:

## A. <u>TECHNICAL PROPOSAL (NOTE: DO NOT INCLUDE ANY COSTS OF ANY</u> <u>KIND IN THIS SECTION.)</u>

- 1. Organizational Qualifications: Describe your experience, capabilities and other qualifications for this project. Include an audited financial statement for the last three (3) years and references (include name of project, point of contact, phone and fax number.) Include three (3) successful CAD Procurement engagements to organizations with similar size and scope to that of DeKalb County. Must provide company name, person to contact, address and telephone number, description of work performed, and the total value of the Contract.
- 2. Technical Approach: Responders are required to describe the procedures and methods that will achieve the required outcome of the project.
- 3. Project Management: Describe how the project will be organized and managed.

Include the anticipated use of subcontractors or vendors. Describe the resources necessary to accomplish the purpose of the project.

4. Personnel: Identify the individuals who will be part of the project team. Include any outside personnel, such as subcontractors.

Provide the following information: Are you a DeKalb County Firm? Yes/No.

#### B. Local Small Business Enterprise Ordinance

It is the objective of the Chief Executive Officer and Board of Commissioners of DeKalb County to provide maximum practicable opportunity for all businesses to participate in the performance of government contracts, including Local Small Business Enterprises (LSBE), Minority Business Enterprises (MBE) and Women Business Enterprises (WBE). See Attachment<u>A</u> of this RFP. The County's *Schedule of Local Small Business Enterprise Participation, Minority Business Enterprise and Women Business Enterprise Opportunity Tracking Form* (Exhibit A) and *Letter of Intent to Perform as a Subcontractor or Provide Materials or Services* (Exhibit B) are included in the Request for Proposal (RFP), along with sample report forms (Exhibit C). The current DeKalb County List of Certified Vendors is included as Exhibit D.

In order for a Proposal to be considered, it is **mandatory** that the Schedule of Local Small Business Enterprise Participation, Minority Business Enterprise and Women Business Enterprise Opportunity Tracking Form (Exhibit A) and Letter of Intent to Perform as a Subcontractor or Provide Materials or Services (Exhibit B) be completed and submitted with responder's proposal.

#### C. Federal Work Authorization Program Contractor and Subcontractor Evidence

#### of Compliance

All qualifying contractors and subcontractors performing work with DeKalb County, Georgia must register and participate in the federal work authorization program to verify the work eligibility information of new employees. Successful responder(s) shall be required to register and participate in the federal work authorization program which is a part of Attachment<u>B</u>, Sample County Contract. In order for a Proposal to be considered, it is **mandatory** that the *Bidder Affidavit*, Attachment<u>C</u>, be completed and submitted with bidder's proposal.

## D. <u>Cost Proposal</u>

The cost proposal must be submitted in a separate, sealed envelope with the responder's name, the request for proposals number, and title of the request for proposal clearly identified on the outside of the envelope.

## DO NOT INCLUDE FEES OR COSTS IN ANY AREA OUTSIDE OF THIS COST PROPOSAL.

Responders are required to submit their costs in accordance to the *Cost Proposal Form*, attachment <u>D.</u>

## V. CONTRACT ADMINISTRATION

#### A. Standard County Contract

The attached sample contract is the County's standard contract document (see Attachment<u>B</u>), which specifically outlines the contractual responsibilities. All responders should thoroughly review the document prior to submitting a proposal. Any proposed revisions to the terms or language of this document must be submitted in writing with the responder's response to the request for proposals. Since proposed revisions may result in a proposal being rejected if the revisions are unacceptable to the County, responders should review any proposed revisions with an officer of the firm having authority to execute the contract. No alterations can be made in the contract after award by the Board of Commissioners.

#### **B.** Submittal Instructions

One (1) Original Stamped "Original" and ten (10) Identical Copies of the Technical Proposal; and one (1) copy of the Cost Proposal must be submitted to the following address no later than 3:00 p.m. on November 2, 2011.

Proposals must be clearly identified on the outside of the envelope with the responder's name, RFP Number, Title for the Request for Proposals.

#### C. Pre-Proposal Conference

#### **D.** Questions

All questions regarding this RFP should be addressed to the Director of the Department of Purchasing and Contracting at the address indicated above. All questions are to be in writing and are to allow sufficient time for distribution to all interested parties. The County will be the sole determiner of sufficient time.

All questions concerning the project shall be submitted to the Director of the Department of Purchasing and Contracting, The Maloof Center, 2<sup>nd</sup> Floor, 1300 Commerce Drive, Decatur, Georgia 30030, in writing no later than 5:00 pm on <u>October 21, 2011</u>. Questions received by the Director of the Department of Purchasing and Contracting after this date will not receive a response.

#### E. Acknowledgment of Addenda

Addenda may be issued in response to changes in the Request for Proposals. Addenda must be acknowledged either in a cover letter or by signing and returning the Addendum form. Acknowledgments must be received no later than the proposal due date. If Acknowledgments are returned with the proposal, they must be submitted with the technical proposal only. Failure to properly acknowledge any Addendum may result in a declaration of non-responsiveness by the County Administration. All addendums issued

for this project may be found on DeKalb County's website, <u>http://www.dekalbcountyga.gov/purchasing/index.htm</u>.

#### F. Proposal Duration

Proposals submitted in response to this RFP must be valid for a period of One Hundred and Twenty (120) days from proposal submission deadline, and must be so marked.

#### G. Project Director

The County will designate a Project Director to coordinate this project for the County. The successful responder will perform all work required pursuant to the contract under the direction of and subject to the approval of the designated Project Director.

#### H. Expenses of Preparing Responses to this RFP

The County accepts no responsibility for any expenses incurred by the responders to this RFP. Such expenses are to be borne exclusively by the responders.

#### I. Georgia Open Records Act

Without regard to any designation made by the person or entity making a submission, DeKalb County considers all information submitted in response to this invitation or request to be a public record that will be disclosed upon request pursuant to the Georgia Open Records Act, O.C.G.A. §50-18-70 <u>et seq</u>., without consulting or contacting the person or entity making the submission, unless a court order is presented with the submission. You may wish to consult an attorney or obtain legal advice prior to making a submission.

## J. First Source Jobs Ordinance

The DeKalb County First Source Jobs Ordinance requires contractors or entities employing 15 or more employees entering into any type of agreement with the County, including purchase orders, regardless of what they may be called, for the procurement or disposal of supplies, services, construction, professional or consultant services, which is funded in whole or part with County funds or County-administered funds in which the contractor is to receive \$50,000.00 or more in County expenditures or committed expenditures to make a good faith effort to hire DeKalb County residents for at least 50% of entry level jobs using the First Source Registry. For more information on this Ordinance requirement, please contact DeKalb Workforce Development at 404.687.3400.

#### K. <u>Business License</u>

Responder shall submit with proposal, a copy of their valid company business license for the State of Georgia. If the State of Georgia has exempted Responder's company from

State licensing, then Responder shall submit proof of that exemption. If Responder has no physical presence in Georgia, or is headquartered in another state, Responder shall provide with bid, a copy of their valid business license or any certificate of authority to transact business awarded to Responder by a governmental authority in the state, province, or country in which the business is headquartered. In addition, Responder must maintain a valid business license or certificate of authority for the duration of the contract.

#### VI. AWARD OF CONTRACT

An evaluation committee will review and rate all proposals and may determine an interview list of the firms whose proposals are highest rated based on qualifications and information provided in Section III, Proposal Format, and Section IV, Criteria for Selection.

Interview listed firms will be scheduled for an oral presentation to the selection committee, not to exceed one hour's duration, responding to questions from the selection committee relevant to the firm's proposal.

The evaluation committee will then re-score all interview listed firms based on the information submitted and oral interview, and will compile a new list ranking those firms. After all rating is completed, the committee will open cost proposals of only the final short listed firms and will include the cost proposal information along with its recommendation for award to the DeKalb County Board of Commissioners, who will make the final decision as to award of contract.

#### ATTACHMENT A SCHEDULE OF LOCAL SMALL BUSINESS ENTERPRISE PARTICIPATION MINORITY BUSINESS ENTERPRISE AND WOMEN BUSINESS ENTERPRISE OPPORTUNITY TRACKING FORM

The Chief Executive Officer and the Board of Commissioners of DeKalb County believe that it is important to encourage the participation of small and local businesses in the continuing business of County government; and that the participation of these types of businesses in procurement will strengthen the overall economic fabric of DeKalb County, contribute to the County's economy and tax base, and provide employment to local residents. Therefore, the Chief Executive Officer and the Board of Commissioners have made the success of local small businesses a permanent goal of DeKalb County by implementing the Local Small Business Enterprise Ordinance.

Certified Local Small Business Enterprises (LSBEs) located within DeKalb County and prime contractors utilizing LSBEs that are locally-based inside DeKalb County shall receive ten (10) percentage points in the initial evaluation of their response to any Request for Proposal and a ten (10) percent preference on all responses to any Invitation to Bid. Certified LSBEs located outside of DeKalb County but within the ten (10) County Metropolitan Statistical Area (MSA) consisting of Cherokee, Clayton, Cobb, DeKalb, Douglas, Fayette, Fulton, Gwinnett, Henry and Rockdale Counties shall receive five (5) percentage points in the initial evaluation of their response to any Request for Proposal and a five (5) percent preference on all responses to any Invitation to Bid.

For all **qualified sealed solicitations**, the Director of Purchasing and Contracting, DeKalb County Government, shall determine if the bidder/proposer has included written documentation showing that **at least twenty percent (20%) of the total contract award will be performed by a certified LSBE.** This written documentation shall be in the form of a notarized Schedule of LSBE Participation (Attached hereto as Exhibit "A".) For all contracts, a signed letter of intent from all certified LSBEs describing the work, material, equipment and/or services to be performed or provided by the LSBE(s) and the agreed upon dollar value shall be due with the bid or proposal documents and included with Exhibit "A". The certified vendor list compiled by the Contract Compliance Division, Purchasing and Contracting Department, DeKalb County Government establishes the group of Certified LSBE's from which the bidder/proposer must solicit subcontractors for LSBE participation.

Contractors failing to meet the LSBE benchmark must document and demonstrate **Good Faith Efforts** in accordance with the attached "Checklist for Good Faith Efforts" portion of "Exhibit A." Failure to achieve the LSBE benchmark or demonstrate good faith efforts may result in a bid or proposal being rejected. The notarized Schedule of LSBE Participation shall be due and submitted with each bid or proposal. **Failure to complete and submit the notarized Schedule of LSBE Participation may result in a bid or proposal being rejected.** 

Upon award, Prime Contractors are required to submit a report detailing LSBE/Sub-Contractor usage with each request for payment and not less than on a monthly basis. Prime Contractors are also required to certify that all sub-contractors have been paid within seven (7) days of the Prime's receipt of payment from the County. Failure to provide requested reports/documentation may constitute a material breach of contract, entitling the County to terminate the Contract for default or pursue other remedies. LSBE sub-contractors must submit a detailed report of their sub-contracting activity for each County contract they participate in. **Sample** Report Forms are attached as Exhibit C.

For eligible bids over \$5,000,000.00, The Director of Purchasing and Contracting or designee will determine if the Mentor-Protégé provision of the Ordinance will apply.

It is the objective of the Chief Executive Officer and Board of Commissioners of DeKalb County to provide maximum practicable opportunity for all businesses to participate in the performance of government contracts, including Local Small Business Enterprises (LSBE), Minority Business Enterprises (MBE) and Women Business Enterprises (WBE). To achieve this purpose, the County would like to track and record information about participating vendors. The attached "Exhibit A," also records who performs work and renders services to the County. Contractors are requested to indicate whether they are a LSBE, MBE or WBE and list the level of participation by subcontractors designated as such on each solicitation.

#### **Bidder/Proposer Statement of Compliance**



WITNESSETH: That for and in consideration of the mutual covenants and agreements herein set forth, the County and the <u>Consultant</u> hereby agree as follows:

### **ARTICLE I. AGREEMENT TIME**

In case of termination of the Agreement before completion of the work, the [Consultant] will

be paid only for the work completed as of the date of termination as determined by the County.

#### **ARTICLE III. SCOPE OF WORK**

The <u>Consultant</u> agrees to provide all professional <u>Computer Aided Dispatch (CAD)</u> <u>Procurement Consulting</u> services in accordance with the County's Request for Proposals (RFP) No.<u>11-500196</u> for <u>Computer Aided Dispatch (CAD)</u> Procurement Consulting Services, attached hereto as Appendix I and incorporated herein by reference, and the <u>Consultant's</u> response thereto, incorporated in its entirety by reference, excerpts of pages \_\_\_\_\_\_ through \_\_\_\_\_\_ of which are attached hereto as Appendix II, and as further specified herein.

#### ARTICLE IV. GENERAL CONDITIONS

- A. <u>Accuracy of Work</u>. The <u>Consultant</u> shall be responsible for the accuracy of the work and any error and/or omission made by the <u>Consultant</u> in any phase of the work under this Agreement.
- B. <u>Additional Work</u>. If the <u>Consultant</u> is asked by the County to perform work beyond the scope of this Agreement for which payment is desired, he shall notify the County in writing, state that the work is considered outside the basic scope of work of this Agreement, give a proposed cost for the additional work, and obtain the approval in writing from the County prior to performing the additional work for which he is to be paid. The County shall in no way be held liable for any work performed under this section which has not first been approved in writing by the County.
- C. <u>Ownership of Documents</u>. All documents, including drawings, estimates, specifications, and data are and remain the property of the County. The <u>Consultant</u> agrees that the County may reuse any and all plans, specifications, drawings, estimates, or any other data or documents described herein in its sole discretion

without first obtaining permission of the <u>Consultant</u> and without any payment of any monies to the <u>Consultant</u> therefore. However, any reuse of the documents by the County on a different site shall be at its risk and the <u>Consultant</u> shall have no liability where such documents are reused.

- D. Successors and Assigns. The County and the Consultant each binds itself and its partners, successors, executors, administrators, and assigns to the other party of this Agreement and to the partners, successors, executors, administrators, and assigns of such other party, in respect to all covenants of this Agreement. Except as above, neither the County nor the Consultant shall assign, sublet, or transfer his interest in this Agreement without the written consent of the other. Nothing herein shall be construed as creating any personal liability on the part of any officers or agent of the County, nor shall it be construed as giving any rights or benefits hereunder to anyone other than the parties to this Agreement.
- E. <u>Reviews and Acceptance</u>. Work performed by the Contractor shall be subject to review and acceptance in stages as required by the County. Acceptance shall not relieve the Contractor of its professional obligation to correct, at his own expense, any errors in the work.
- F. <u>Termination of Agreement</u>. The County may unilaterally terminate this Agreement, in whole or in part, for the County's convenience, or because of failure of the Contractor to fulfill the obligations of this Agreement in any respect. The County shall terminate by delivering to the Contractor, with at least thirty (30) days notice, a Notice of Termination specifying the nature, extent, and effective date of

termination. If terminated by the County, the written notice shall be sent to the Consultant, addressed as follows:

All notices sent to the above address shall be binding upon the <u>Consultant</u> unless said address is changed by the Contractor in writing to the County. If this Agreement is so terminated, the Contractor shall be paid as provided hereinbefore.

- G. Indemnification Agreement. As between the County and the Contractor as the other party, the Contractor shall assume responsibility and liability for any damage, loss, or injury, including death, of any kind or nature whatever to person or property, including employees and property of the County, caused by or resulting from any error, or omission of the Contractor, or the negligent act of the Contractor or its subcontractors or any of their officers, agents, servants, or employees, arising from the performance of the work under this Agreement. The Contractor shall defend, indemnify, and hold harmless the County and all of its officers, agents, servants, or employees from and against any and all claims, loss, damage, charge, or expense to which they or any of them may be put or subjected by reason of any such damage, loss, or injury. The Contractor expressly agrees to defend against any claims brought or actions filed against the County, where such claim or action involves, in whole or in part, the subject of the indemnity contained herein, whether such claims or actions are rightfully or wrongfully brought or filed.
- H. **Insurance.** The Contractor shall furnish the following along with the Agreement documents sent to the County for execution:

- 1. Certificates of Insurance in companies doing business in Georgia and acceptable to the County covering:
  - (a) Statutory Workers' Compensation Insurance, or proof that <u>Consultant</u> is not required to provide such coverage under State law;
  - (b) Professional Liability Insurance on the Contractor's services in this Agreement with limit of \$1,000,000;
  - (c) Commercial General Liability Insurance covering all operations with combined single limit of \$1,000,000;
  - (d) Comprehensive Automobile Liability Insurance with form coverage for all owned, non-owned and hired vehicles with combined single limit of \$500,000.
  - (e) Umbrella or Excess Insurance is acceptable to meet the minimum limits whenever there is an insurer licensed to do business in Georgia which is providing at least the first \$100,000 of primary coverage.
- 2. Certificates of Insurance must be executed in accordance with the following provisions:
  - (a) Certificates to contain policy number, policy limits, and policy expiration date of all policies issued in accordance with this Agreement;
  - (b) Certificates to contain the location and operations to which the insurance applies;
  - (c) Certificates to contain Contractor's protective coverage for any

subcontractor's operations;

- (d) Certificates to contain Contractor's contractual liability insurance coverage;
- (e) Certificates are to be **issued** to:

- 3. The Contractor shall be wholly responsible for securing certificates of insurance coverage as set forth above from all subcontractors who are engaged in this work.
- The Contractor agrees to carry statutory Workers' Compensation
   Insurance and to have all subcontractors likewise carry statutory Workers'
   Compensation Insurance.
- I. <u>Georgia Laws Govern</u>. This Agreement shall be governed by and construed and enforced in accordance with the laws of Georgia.
- J. <u>Venue</u>. This Agreement shall be deemed to have been made and performed in DeKalb County, Georgia. For the purposes of venue, all suits or causes of action arising out of this Agreement shall be brought in the courts of DeKalb County, Georgia.

## K. <u>Contractor and Subcontractor Evidence of Compliance</u>

 County contracts for the physical performance of services within the state of Georgia shall include the following provisions in accordance with O.C.G.A. § 13-10-91, as amended:

- (a) the contractor has registered with and is authorized to use the federal work authorization program to verify information on all newly hired employees or subcontractors;
- (b) by affidavit, the contractor must attest to the contractor's name, address, user identification number, date of authorization, and verification of the continual participation throughout the contract period, and
- (c) the affidavit shall become a part of the covered contract and must be attached.
- 2. No contractor or subcontractor who enters into a contract with the County or a contractor of the County shall enter into such a contract or subcontract in connection with the physical performance of services within Georgia unless the contractor or subcontractor registers and participates in the federal work authorization program to verify information of all newly hired employees. Any employee, contractor, or subcontractor of such contractor or subcontractor shall also be required to satisfy the requirements of O.C.G.A. § 13-10-91, as amended.
- 3. Upon contracting with a new subcontractor, a contractor or subcontractor shall, as a condition of any contract or subcontract entered into pursuant to O.C.G.A. § 13-10-91, as amended, agree to provide the County with notice of the identity of any and all subsequent subcontractors hired or contracted by the contractor or subcontractor. Such notice shall be provided within five (5) business days of entering into a contract or agreement for hire with any subcontractor. Such notice shall include an affidavit from each subsequent contractor attesting to the subcontractor's name, address, user identification number, and date of authorization to use the federal work authorization program.
- 4. An affidavit shall be considered an open public record; provided, however, that any information protected from public disclosure by federal law or by Article 4 of

Chapter 18 of Title 50 shall be redacted. Affidavits shall be maintained by the County for five years from the date of receipt.

- 5. To verify compliance, the contractor agrees to participate in random audits conducted by the Commissioner of the Georgia Department of Labor. The results of the audits shall be published on the <u>www.open.georgia.gov</u> website, and on the Department of Labor's website no later than December 31 of each year.
- 6. Any person who knowingly and willfully makes a false, fictitious, or fraudulent statement in an affidavit submitted pursuant to O.C.G.A. § 13-10-91 shall be guilty of a violation of Code § 16-10-20 and, upon conviction, shall be punished as provided in such section. Contractors and subcontractors convicted for false statements based on a violation of such section shall be prohibited from bidding on or entering into any public contract for twelve (12) months following such conviction.
- L. <u>Modification</u>. This Agreement may be modified or amended by the County to adjust the scope of work or project description upon seven (7) days written notice.
  All notices sent to the Consultant's address shall be binding upon the Consultant unless said address is changed by the Consultant in writing to the County. The written notice shall be sent to the Consultant addressed as follows:

M. <u>County Representative</u>. The County may designate a representative through whom the Consultant will contact the County. In the event of such designation, said representative shall be consulted and his written recommendation obtained before any request for extra work is presented to the DeKalb County Board of Commissioners. Payments to the Consultant shall be made only upon itemized bill submitted to and approved by said representative.

- N. <u>Contractor's Status</u>. The relationship between the County and the Contractor shall be that of owner and independent contractor. Other than the consideration set forth herein, the Contractor shall not be entitled to any employee benefits including, but not limited to, insurance, paid annual leave, sick leave, worker's compensation, free parking or retirement benefits.
- O. <u>Georgia Open Records Act</u>. Without regard to any designation made by the person or entity entering this Agreement, DeKalb County considers all information submitted in response to this Agreement to be a public record that will be disclosed upon request pursuant to the Open Records Act O.C.G.A. § 50-18-70 <u>et seq</u>., after contacting the person or entity making the submission, unless a court order is presented with the Agreement.
- P. First Source Jobs Ordinance. The DeKalb County First Source Jobs Ordinance requires contractors or entities employing 15 or more employees entering into any type of agreement with the County, including purchase orders, regardless of what they may be called, for the procurement or disposal of supplies, services, construction, professional or consultant services, which is funded in whole or part with County funds or County-administered funds in which the contractor is to receive \$50,000.00 or more in County expenditures or committed expenditures to make a good faith effort to hire DeKalb County residents for at least 50% of entry level jobs using the First Source Registry. For more information on this Ordinance requirement, please contact DeKalb Workforce Development at 404.687.3400.

- P. <u>Sole Agreement</u>. This Agreement constitutes the sole agreement between the parties. No representations oral or written not incorporated herein shall be binding on the parties. No amendment or modifications of this Agreement shall be enforceable unless approved by action of the Board of Commissioners of DeKalb County.
- Q. <u>Controlling Provisions.</u> In the event of a conflict between the County's RFP No.
   <u>11-500196</u> and the <u>Consultant's</u> response thereto, the provisions of the County's RFP shall govern. The provisions of this Agreement shall control over any conflicting provisions contained in the <u>Consultant's</u> response.
