NOTICE TO BIDDERS

Sealed Bids on behalf of the County of Chesterfield, Virginia, will be received in the Chesterfield County Purchasing Department, 9842 Lori Road (Court Square), Suite 101, Chesterfield, VA 23832 until but no later than **2:00 P.M.** local time prevailing, **May 10, 2011**, and then publicly opened and read immediately thereafter for the **construction** of the following:

Hopkins Road Waterline Replacement from Centralia to Route 288: The project includes the abandonment (in place) of $\underline{4.250}$ Liner Feet (LF) of existing 10-inch Asbestos Cement water line, the replacement (up to the property line) of $\underline{15}$ water services from the main (bored or jacked across the roadway) to the proposed meter location, the replacement (up to the property line) of $\underline{12}$ water services from the main (jacked or bored) to the proposed meter location, the installation of $\underline{55}$ LF of proposed 8-inch ductile iron water line, the installation of $\underline{235}$ LF of proposed 12-inch ductile iron water line, the installation of $\underline{5}$ fire hydrant assemblies, the tie-in of the proposed water lines to the existing water lines along Centralia Road, Jaymont Drive, Old Cannon Road, and Alfaree Road, and all associated work (including asphalt mill and overlay as required to complete the installation described herein.
