Description

The STATE OF MONTANA, Office of Public Instruction (OPI) ("State") is seeking to engage with a web design vendor to assist the OPI with redesigning and deploying a new website. The overall goal is to produce a website that is a simple to use, responsive (mobile-friendly) and makes it easy to find timely and relevant information. The selected vendor would provide website design services, configuration of the content management system to allow for edit/publish workflows and build out the website "framework" to accept content. OPI staff would be responsible for moving content from the current website to the new website and all ongoing maintenance of content. OPI staff would also be responsible for populating the content management system with users and ongoing maintenance. The new website would be hosted in the State of Montana's Information Technology Services Division enterprise web-hosting and content management environment.

The project is expected to begin in March 2017 and end August 2017.
