**NOTICE IS HEREBY GIVEN THAT** the City of Palo Alto will receive sealed bids for the performance of the work described as Storm Drain Rehabilitation Project, Invitation for Bids (IFB) No. 142706 until 3:00 p.m., Tuesday, August 30, 2011, at which time bids will be publicly opened and read aloud at the City Hall Offices, City Council Conference Room, First Floor, 250 Hamilton Avenue, Palo Alto, CA 94301.

A **MANDATORY** pre-bid conference is scheduled for this project on Thursday, August 18, 2011 at 10:00 a.m. at the Regional Water Quality Control Plant Maintenance Lunchroom located at 2501 Embarcadero Way, Palo Alto.

General Description of Work:

The work consists, in general, providing Replacement of existing storm drains, and installation of new storm drains, and miscellaneous accessories at the Regional Water Quality Control Plant, including all incidental and related work. The work is more fully described in the Contract Documents.

The estimated cost of construction is \$250,000.00.

The Bidder to whom the Contract will be awarded must, at the time of bid submittal, possess current licenses in the following classification issued by the California State Contractors License Board: Class A (General Engineering). Bidder's subcontractors must also be properly licensed.
