Tender enquiry for 'Supply, installation & commissioning of long range Wireless Access Point'.

Jawaharlal Nehru Port Trust (JNPT), Navi Mumbai is inviting Tenders for '**Supply, installation & commissioning of long range wireless access point**'. The proposals shall be as per following terms and conditions:

1. **The detail Notice Inviting Tenders (NIT) is as below:**

I.	Name of work	'Supply, installation & commissioning of long range wireless access point'.
II.	Cost of Tender Document:	Rs.1,000/- (Rupees One thousand only) including all taxes in the form of Demand Draft only , drawn in favour of "Jawaharlal Nehru Port Trust" Payable at Mumbai and shall be submitted along with the Bid.
III.	Earnest Money Deposit (EMD)	Rs.4,400/- (Rupees Four thousand four hundred only) in the form of Demand Draft only , drawn in favour of "Jawaharlal Nehru Port Trust" Payable at Mumbai and shall be submitted along with the Bid..
IV.	Exemption of EMD / Cost of tender document	SSI units registered with NSIC are entitled for exemption of EMD / Cost of tender document. Copy of valid NSIC certificate, shall reach the destination before the stipulated time & date of opening of the Bids.
V.	Due date for submission of Tender	On or before 16/02/2017 up to 1500 hrs

VIII.	Work Completion Period	10 Days from the date of issue of LOA or Work Order.
IX.	Liquidated Damages	In case of delay beyond stipulated completion period, the Employer shall be entitled to recover from the Contractor liquidated damages @1% per week subject to maximum limit of 5% of basic value of the order. Applicable service tax will be levied on LD amount.

The bid of any bidder who doesn't meet minimum eligibility criteria and / or fail to submit the required documents as mentioned above are liable to be summarily rejected.

- Site visit:** Interested bidders are advised to visit Jawaharlal Nehru Port Trust, Tal- Uran, Navi Mumbai – 400 707, before submission of the offer, in order to make fully aware of the work to be carried out and the working conditions. The cost of visiting the sites shall be at the Bidder's own expenses.
- Scope of work:** The scope of work includes supply, installation, testing & commissioning of outdoor long range Wireless Access Point on Towers / Poles at various locations of JNPT i.e., PP & D site office, Seamens Building, Admin Building etc. The work shall be under warrantee and support of one year. Under warrantee and support period, compulsory monthly preventive maintenance of Access Point during last week of calendar month. All complaints shall be attended and rectified within 24 hours from the time of complaint lodged with your office (communicated through telephone / fax / email / letter).
- Bill of Quantity & Total cost:** The total cost of the work is required to be submitted in format given below.

6. **Payment terms:**

- a) Ninety percent (90%) of the total contract value shall be released on successful completion of specified work. After successful commissioning of the said work, bidder must submit the warrantee certificate for complete work for the period of 01 year.
- b) Ten percent (10%) of the total contract value shall be retained as "Performance Security" during warrantee period of 01 year and shall be released on satisfactory completion of warrantee period of 01 year. OR balance 10% of the total contract value shall be released after successful commissioning of the said work, against submission of Bank Guarantee. This bank guarantee should be valid for 15 months along with claim period of 03 months.

7. **Penalty:** If, fails to rectify the complaints within stipulated time or monthly preventive maintenance, 0.2 % of the total contract value as penalty per day shall be recovered from Performance Guarantee deposit.

8. **Forfeiture of EMD**

- a) Withdrawal of proposal within the period of Proposal validity lead to forfeiture of EMD
- b) Any Misrepresentation of facts & figure during the bidding process leads to forfeiture of EMD
- c) Indulging in unscrupulous activities by the bidders or its affiliates leads to forfeiture of EMD
- d) In case the bidder is found blacklisted during the selection process, JNPT reserves the right to disqualify such bidder and may lead to forfeiture of the EMD.
- e) If any commercial/financial information is disclosed as part of the Pre-qualification/Technical Bid, this leads to forfeiture of EMD
- f) If the bidder fails to accept the Purchase Order/ Work Order, this leads to forfeiture of EMD

9. **Termination of the contract:** JNPT reserves the right to terminate the contract at any time, if the performance is found not satisfactory.

10. **Tax deductions:** Deductions of income tax and / or any other Applicable taxes shall be made from amount payable to you as per provision of Income Tax Act or any other Act. Taxes will be paid as per prevailing applicable rate.


